**Director's Report** – Director Poole gave the Director's Report and shared the Bank Reconciliation Report for August 2023.

Director Poole provided an update to the Board of her presentation to the Committee of the Whole of County Council on September 12, 2023. In the presentation, she reviewed the Collection Development Policy and the Library's roles and responsibilities that are defined within the policy, and she explained to the Committee the book selection and cataloging process. She described the Parenting Collection and the importance of a balanced collection and parental oversight. Director Poole expressed her gratitude that several Board members attended the Committee meeting and emphasized the importance of the Library Board's support.

Director Poole informed the Board that the Library will reinstate the Young Adult and the Juvenile Adult Material Selection committees (YAMS and JAMS) to evaluate the content and developmental age level of appropriateness of YS books and to determine the best shelf locations for them in the library system, and a Parenting Collection was added to the Collection Development Policy to have a space for books that would be best shared by a caregiver with a child.

Director Poole reminded the Board that Staff Education Day will be held at the Lexington Municipal Complex on October 6, 2023. All library branches will be closed that day to allow for all staff members to attend, and Board members are welcome to attend as well.
